Payment Schedule

- a) **First Payment:** \$ 600 (non-refundable) when the student applies for enrollment.
- b) **Second Payment:** \$ 3,186 non-refundable I-20, Government processing fees, student visa fee. (In addition, Dependent Visa cost is calculated separately at \$200.00 per dependent visa).
- c) **Third Payment:** \$ 5,700 tuition fee after receiving I-20, which indicates MIAS has enrolled the student. If the student can not successfully go to the United States because of failing to obtain the student visa or withdraws due to unexpected circumstances, MIAS shall refund 50% of the tuition fee after the receipt of withdrawal letter for that student. The non-refundable amount will not be refunded. MIAS will provide invoice for all payments.
- d) **Fourth Payment:** The remaining fees \$ 2,805, (MACTE-AMS registration \$500; course Manuals, Books and materials \$805; and Administrative cost \$1,500) will be paid before or on arrival.
- e) Other fees may also include the cost of postage for mailing documents if needed.

Tuition must be paid in full before the student can begin courses with the Institute.

- ❖ Housing, transportation, food, and living expenses while in the US are the responsibility of the student.
- ❖ The cost of course manuals and books are included in the tuition listed above.
- ❖ **The cost of the Child Development course and First Aid & CPR class are not included in the tuition or other fees listed above.**
