Payment Schedule

1. **First Payment:** \$250 (non-refundable) or \$350 (non-refundable) deposit toward tuition when the student applies for enrollment.
2. **Second Payment:** \$ 3350 non-refundable I-20, Government processing fee, and the Administration cost, when the I-20 is issued. The dependent visa fee of \$200 for each dependent is due at this time.
3. **Third Payment:** \$5800 tuition fee after receiving I-20, which indicates MIAS has enrolled in the student. If the student cannot successfully go to the United States due to failing to obtain a student visa or withdraws before coming to the States due to unexpected circumstances, MIAS shall refund the \$4000 tuition fee after receiving the withdrawal letter for that student.

The non-refundable amount will not be refunded. MIAS will provide an invoice for all payments.

4. **Fourth Payment:** The remaining amount of \$1838 covers the costs of course manuals, books, materials, AMS and MACTE adult learners registration fees, practicum fee, and the supervised practice fee. This payment is due before or upon arrival.
